Sunique International Cabinets Warranty

Congratulations on your new cabinets! Sunique International takes pride in providing high-quality cabinetry that is designed to last for years to come. To protect original customer's investment, Sunique International offers the following warranty coverage for the cabinets:

Warranty Coverage

Sunique International warrants that the cabinets will be free from defects in materials and workmanship under normal use for a period of 1 year from the date of purchase. The liability under this warranty is limited to the repair or replacement of defective cabinet parts, as stated above. Some replacement parts are subject to availability and may differ from the original parts received. We are not liable for any other damages, including but not limited to incidental or consequential damages, loss of use, loss of time, or labor charges for removal or installation of the cabinets.

Natural woods can exhibit color, grain, and characteristic variations as they age, which are not considered defects. Sunique International is not responsible for these variations in cabinetry and will not be held liable. For instance, painted doors, drawer fronts, and face frames may develop visible cracks around joints, and cabinet colors may darken or lighten over time. These are considered normal occurrences and are not covered by the limited liability warranty.

The glazed finish intentionally creates an uneven appearance, with variations in edges, profiles, and glazing from cabinet to cabinet, door to drawer, and item to item. This may result in overall color variations, but it is not considered a defect. Environmental factors such as UV light, sunlight, smoke, household cleaners, and others may also affect the color and integrity of the product's finish or appearance over time. However, these variations are considered inherent to the material's nature in relation to its environmental exposure and are not defects in material or workmanship, and thus, are not covered under the Limited Warranty provided.

Claim Process

To make a claim under this warranty, please provide proof of purchase and a detailed description of the issue in writing or by phone. Sunique International may request additional information or inspect the cabinets in person to determine the nature of the defect and the appropriate course of action.

Exclusions

This warranty does not cover damage caused by misuse, abuse, neglect, improper installation, normal wear and tear, or environmental conditions such as exposure to excessive moisture, extreme temperatures, or direct sunlight. Temperature outside the range of 50-85°F and humidity outside the range of 30-55% are considered extreme. It also does not cover modifications or alterations made to the cabinets after installation, or damage caused by acts of nature or accidents.

Transferability

This warranty is only valid for the original purchaser of the cabinets and is not transferable to subsequent owners.

Governing Law

This warranty shall be governed by the laws of Texas USA, without regard to its conflicts of law provisions.
